An Act to amend the Gilgit-Baltistan Legislative Assembly

Chief Minister/Ministers (Salaries, allowances and Privileges) Act, 2010.

Whereas it is expedient to amend the Gilgit-Baltistan Legislative Assembly Chief Minister/Ministers (Salaries, Allowances and Privileges) Act, 2010, in the manner hereinafter appearing;

Preamble

It is hereby enacted as follows:—

1. This Act may be called the Gilgit-Baltistan
Legislative Assembly Chief Minister/Ministers
(Salaries, Allowances and Privileges)
(Amendment) Act, 2015.

Short title and commencement

It shall come into force at once.

In the said Act, in sub-section 3(1), for the words "seventy thousand" and "fifty thousand", the words "two hundred and fifty thousand" and "one hundred thousand" shall be substituted respectively.

3. In the said Act, in sub-section 6(1) ad 6(2), for the words "forty thousand" and "thirty thousand", the words "one hundred and fifty

thousand" and "eighty thousand" shall be substituted respectively.

4. In the said Act, in section 7, for the words "ten thousand", the words "fifty five thousand" shall be substituted.

5. In the said Act, in sub section 10 (2), the words "sixty five thousand" shall be substituted for the words "thirty five thousand".

Amendment of Sub-Section 10 (2) of GBLA Act No. V.

6. In the said Act, from sub-section 10(3), the term 'Gas' shall be scraped out.

Amendment of Sub-Section 10 (3)

7. In the said Act, in place of sub-section 16, the following new sub-section 16(1) shall be added: "A Minister and his family shall be entitled to Medical facilities at Government expense for the following diseases:

- 8. In the said Act, the following sub-section 16(a) shall be added:
 "16 (a) A Minister shall be entitled to Medical allowance of "twenty five thousand rupees" per month.

Addition of Sub Section 16 (a)

9. In the said Act, the following sub-section 20 (6) shall be added:
"20 (6) A Minister shall be paid Gas bill worth

Addition of Sub-Section 20 (6)

10. In the said Act, from section 22, the term 'cellular phone' shall be scraped out.

"fifteen thousand rupees" per month".

Amendment of section 22

11. In the said Act, the following sub-section 22 (a) shall be added;

Addition of Sub-Section 22 (6)

"22 (a) A Minister shall be entitled to Mobile expense of "twelve thousand rupees" per month.

Addition of section 25

12. In the said Act, the following new section 25 shall be added:

"(25) Any provisions regarding increase in the

salary of Chief Minister / Minister in proportion to the increase in the salary of civil servants shall no longer be applicable".
