THE GBLA SPEAKER

(Salaries, Allowances and Privileges) (Amendment) Act, 2010

(GBLA ACT NO. I OF 2015)

An Act to amend the Gilgit Baltistan Legislative Assembly Speaker (Salaries, Allowances and Privileges) Act, 2010.

Whereas it is expedient to amend the Gilgit Baltistan Legislative Assembly Speaker (Salaries, Allowances and Privileges) Act, 2010, in the manner hereinafter appearing;

Preamble

It is hereby enacted as follows:—

1. This Act may be called the Gilgit Baltistan Legislative Assembly Speaker (Salaries, Allowances and Privileges) (Amendment) Act, 2015.

Short title and commencement

It shall come into force at once.

2. In the Gilgit Baltistan Legislative Assembly Speaker (Salaries, Allowances and Privileges) Act, 2010, hereinafter referred to as the said Act, in section 3, for the words "fifty two thousand five hundred and fifty", the words "one hundred twenty thousand" shall be substituted. **Amendment of section 3 of the GB Legislative Assembly Act No. II of 2010.**
3. In the said Act, in section 5, for the words "twenty five thousand", the words "seventy five thousand" shall be substituted. **Amendment of section 5 of the GB Legislative Assembly Act No. II of 2010.**
4. In the said Act, from sub section 7(3) the term gas charges shall be scraped out. **Amendment of sub-section 7(3) of the GB Legislative Assembly Act, No. II of 2010**
5. In the said Act, in section 12, for the words "ten thousand five hundred fifty", the words "sixty five thousand" shall be substituted. **Amendment of section 12 of GBLA Act No. II of 2010.**
6. In the said Act, in section 16, the following new sub-section shall replace the old one:
"The Speaker and his family shall be entitled to Medical facilities at Government expense for the following diseases:
Cancer
Hepatitis C
Heart
Replacement of old section 16 with new one
7. In the said Act, the following new sub section shall be added:—
"16(i) The Speaker shall be entitled to receive medical allowance at the rate of "thirty thousand" rupees per month". **Addition of sub-section 16(i) of GBLA Act No. II**
8. In the said Act, in sub-section 7(3), for the words "forty five thousand", the words "seventy five thousand" shall be substituted. **Amendment of sub-section 7(3) of GBLA Act No. II**
9. In the said Act, from section 21, the term mobile phone shall be scraped out. **Amendment of section 21 of GBLA Act No. II**

10. In the said Act, the following new sub-section shall be added:
“21(a) the Speaker shall be entitled to receive Mobile expense worth “fifteen thousand rupees” per month”.
- Addition of sub-section 21(a) in GBLA Act No. II**
11. In the said Act, the following new section shall be added:
“(26) The Speaker shall be paid gas bill equal to “twenty thousand rupees” per month”.
- Addition of new section 26 in GBLA Act No. II**
12. In the said Act, the following new section 27 shall be added:
“(27) All the provisions regarding increase in the salary of Speaker in proportion to the increase in the salary of civil servants shall no longer be applicable.
- Addition of section 27 in GBLA Act No. II**
