I am directed to refer to Gilgit Baltistan Assembly Secretariat letter No. Legis-1(5)/2020 dated 8th September, 2023 on the subject cited above and to forward reply as;

- The Department of Tourism & Culture GB has initiated a case with S & GAD Department GB on 1st March, 2023 vide Tourism Secretariat GB letter No. 2(30)/2017/2377. to provide 12 Nos. of Inspectors & 03 Nos. of Law Officers to function Department of Tourist Services properly
- The Services & GAD Department further circulated a letter to all Administrative Secretaries to provide 12 Nos. of Inspectors & 03 Nos of Law Officers on deputation basis (copy attached) but still no any incumbent has joined this office.
- The Directorate of Tourism & Culture GB had initiated a fresh case for creation of 12 No. posts of Inspectors & 03 posts of Law Officers vide this office letter No. DoT-Admin-1(03)/2022 dated 16th March, 2022 but still a positive response is awaited. Without provision of required staff or creation of posts of Inspectors and Law Officers the functioning of DTS is quite difficult.
- However, this Directorate has started registration & renewal of Tour
 Operators and Tour Guides with its limited recourses.
